IF YOU DO NOT AGREE TO ALL OF THE TERMS OF USE, **DO NOT** ACCESS OR USE THE BLUEMESH COMMISSIONING. IF YOU HAVE ALREADY DOWNLOADED OR INSTALLED THE BLUEMESH COMMISSIONING AND YOU DO NOT AGREE TO THE TERMS OF USE, THEN DELETE THE BLUEMESH COMMISSIONING IMMEDIATELY.

1. User Eligibility

BlueMesh Commissioning is offered to you and the entity you are authorized to represent ("You") by Above All Lighting, Inc., and is provided and operated by BlueMesh with its main office at 1135 Thomas Busch Memorial HWY, Pennsauken, NJ 08110, USA ("BlueMesh"), email: <u>support@BlueMesh.us</u>. By clicking the "I Accept" button or checkbox presented with these Terms of Use, or by downloading, installing, accessing or using any portion of the BlueMesh Commissioning, you signify your agreement to be bound by these Terms of Use.

The BlueMesh Commissioning applies only to entities and persons over the age of legal majority who can form legally binding agreement(s) under applicable law. If you do not qualify, you are not permitted to use the BlueMesh Commissioning.

2. Scope of Terms of Use

These Terms of Use govern your access and use of the BlueMesh Commissioning and are legal and binding agreements between You and BlueMesh.

You acknowledge full responsibility for the legal and responsible access to and use of the BlueMesh Commissioning.

The BlueMesh Commissioning means collectively: the combined web, the mobile app and all associated cloud computing.

You are entitled to use the BlueMesh Commissioning solely: (a) for the purpose of configuration and managing the compatible devices, i.e. devices containing version of BlueMesh's firmware which is operable by the BlueMesh Commissioning or other compatible devices recommended by BlueMesh (collectively "**Device**") and (b) which have been installed in the lighting system based on Bluetooth Mesh standard ("**Lighting System**").

The BlueMesh Commissioning provides the features, functionalities defined in the BlueMesh Commissioning documents, including technical requirements, users manuals and instructions (collectively "**Documentation**") available at <u>www.BlueMesh.us</u>. Please read this Documentation before using the BlueMesh Commissioning. The Documentation may be amended by BlueMesh from time to time without notice. You are advised to regularly review the Documentation.

Please note that some of the functionalities or access to the BlueMesh Commissioning may be restricted due to external requirements or provision of law applicable in some territories. Therefore BlueMesh does not guarantee that the BlueMesh Commissioning will be available for usage in all locations.

These Terms of Use may be revised and updated at any time and due to BlueMesh's sole discretion, in particular due to the improving of the quality of the services provided, changing of the business strategy, adapting to mandatory law regulations. By downloading, installing, accessing or continuing using any portion of the BlueMesh Commissioning, you will be deemed to have accepted such amendments. 3. Access to and use of the Commissioning Tool. Account

Using the BlueMesh Commissioning is permissible provided that Your device/mobile device meets jointly the following minimum technical requirements:

For the web application: (a) has access to the Internet, (b) allows the start-up of from the most recent version of internet browsers Google Chrome.

For the mobile application: (a) has access to the Internet, (b) has the most recent version of the iOS or Android system.

If you access or use the BlueMesh Commissioning on a wireless device, note that your wireless or cellular provider may charge fees or data usage for the BlueMesh Commissioning, all of which are at your cost.

These Terms of Use are between You and BlueMesh and we are responsible for maintaining BlueMesh Commissioning, not any third party distribution channel (i.e. Apple, Google Ireland, or its affiliates (collectively as "Distributors")). You and BlueMesh acknowledge and agree that Distributors and its subsidiaries are third party beneficiaries to this agreement and, upon your acceptance of these Distributors' Terms of Use will have the right (and will be deemed to have accepted the right) to enforce this agreement as a third party beneficiary thereof. Using the BlueMesh Commissioning and associated features, requires registration and creation of Your personal user account ("Account").

You may be asked to provide certain information (e.g. name, email address, country, company name, phone number). This information is requested and maintained by BlueMesh pursuant to the BlueMesh Commissioning Privacy Notice, available at <u>www.BlueMesh.us</u>. Under the BlueMesh Commissioning Privacy Notice, You agree to provide BlueMesh with information that is accurate and that belongs to You. You also agree to update BlueMesh promptly if and when any of the Account information changes.

You shall be asked to create login credentials when setting up your Account. Keep your login credentials secure and private and do not share your information with anyone. You are responsible for ensuring that this information remains confidential, and any conduct, action, inaction or negligence – made in your Account or by you or your device in the BlueMesh Commissioning are your responsibility, whether authorized or unauthorized. You are also responsible for restricting access to your computer(s) or mobile device(s) on which you use or access the BlueMesh Commissioning. You should immediately notify BlueMesh of any unauthorized access to your accounts.

BlueMesh reserves the right to require our prior or later acceptance for registration. We have a right to refuse the registration, in particular if you have previously violated the Terms of Use. The BlueMesh Commissioning currently supports specific user roles in the projects created in the BlueMesh Commissioning e.g. a project owner, a manager, an installer, and an end-user, as described in the Documentation. Please be aware that particular rights and obligations concerning the performance of the BlueMesh Commissioning belong to the specific user-roles and its Account. Therefore you are advised to read the Documentation carefully. BlueMesh reserves the right to refuse to: regain access to the Account (in case of deletion of the Account), or transfer access to the Account to any third party. Therefore, if You use the BlueMesh Commissioning as a "project owner", You and a tenant or the owner of the property where the Lighting System is operating, shall be responsible to secure access to the project created by using the BlueMesh Commissioning.

You are entitled to delete the Account at any time by using the "Delete the account" function in the My Account section of the BlueMesh Commissioning. By deleting the Account, you terminate this Agreement and you may not be able to restore access to your Account.

4. License and Ownership

The BlueMesh Commissioning is licensed, not sold. With the exception of intellectual property used in the BlueMesh Commissioning that is owned by the Bluetooth SIG, Inc., or by the third party, any and all intellectual property rights and its content (collectively "Intellectual Property") associated with the BlueMesh Commissioning are protected by copyright and other laws, and will remain BlueMesh sole property. Elements of the BlueMesh Commissioning are also protected by trademark, trade secret, unfair competition, and other laws and may not be copied or imitated in whole or in part.

All custom graphics, icons, and other items that appear in the BlueMesh Commissioning are trademarks, service marks or trademark ("**Marks**") of BlueMesh, its affiliates or other entities that have granted BlueMesh the right and license to use such Marks and may not be used or interfered with in any manner without the express written consent of BlueMesh.

Except as otherwise expressly authorized by these Terms of Use, you may not copy, reproduce, modify, lease, loan, sell, create derivative works from, upload, transmit, or distribute the Intellectual Property of the BlueMesh Commissioning and its Content in any way without the BlueMesh's or the appropriate third party's prior written permission. Except as expressly provided herein, BlueMesh does not grant to you any express or implied rights to the BlueMesh's or any third party's Intellectual Property.

Subject to your compliance with these Terms of Use and without prejudice to any other terms set forth in these Terms of Use, BlueMesh, grants You a limited, personal, non-exclusive, revocable right (a) to access and use the BlueMesh Commissioning (including Documentation) only in the manner presented and expressly permitted by BlueMesh, and (b) to transfer this license to the third party (e.g. legal owner or tenant of the building where the Lighting System has been commissioned by the BlueMesh Commissioning). In the scope of the license, You are also entitled to create user-roles accounts and give the access to them to Your associates. The license to use the BlueMesh Commissioning granted under these Terms of Use remains in effect until terminated by You or BlueMesh.

Except for this limited license, BlueMesh does not convey any interest in or to the BlueMesh Commissioning, information or data available via the BlueMesh Commissioning (the "Information"), content or any other BlueMesh's or any third party's property by permitting you to access the BlueMesh Commissioning. Except to the extent required by law or as expressly provided herein, none of the content and/or Information may be reverse-engineered, modified, reproduced, re-published, translated into any language or computer language, re-transmitted in any form or by any means, resold or redistributed by you without the prior written consent of BlueMesh. You may not make, sell, offer for sale, modify, reproduce, display, publicly perform, import, distribute, retransmit or otherwise use the content in any way, unless expressly permitted to do so by BlueMesh.

In accordance with the use of BlueMesh Commissioning, You may be able – at Your own risk – to submit to the Account: information, materials, data and parameters concerning performance of the BlueMesh Commissioning, Lighting System and Devices (e.g. names, project details, area, zones, locations, parameters, scheduling events, protile type etc.) ("**User Content**"). The User Content concerns also data or materials generated by you by using the BlueMesh Commissioning. You hereby confirm that you: (i) are solely responsible for this User Content, in particular you obtained all required consent under applicable law to use and submit such Content to the BlueMesh Commissioning, and/or (ii) you have a legal right to this Content. You agree not to provide inaccurate, misleading or false information in connection with your use of the BlueMesh Commissioning and in particular in connection with your Account for the BlueMesh Commissioning. Do not add personal data to User Content. BlueMesh does not screen or evaluate the User Content uploaded by You to the BlueMesh Commissioning. You acknowledge that You are solely liable for User Content, in particular for any third party intellectual property claims or violation of any applicable law. BlueMesh liability is excluded thereof.

You hereby grant BlueMesh the exclusive, irrevocable, perpetual, worldwide, royalty-free, transferable and sub-licensable, license to store, use, modify, reproduce, publish, distribute, transfer, translate, publicly display and exploit User Content submitted or generated by you in any form and its derivative works – for the purpose of performance of the BlueMesh Commissioning and any other services provided by BlueMesh without notifying you thereof. To the maximum extent permitted by applicable law and under given license herein – you hereby waive any moral right to the User Content. This license and waiver of moral rights shall survive the termination of the use of the BlueMesh Commissioning.

You also acknowledge that BlueMesh also allows you to collaborate on the User Content of other BlueMesh Commissioning users. The user of the BlueMesh Commissioning who acts as a "project owner" might control and have access to your User Content in the particular projects created by BlueMesh Commissioning.

5. Restrictions on Use of the BlueMesh Commissioning

In addition to other restrictions set forth in these Terms of Use, you agree that:

- (a) You are, at your own risk, responsible for your use of the BlueMesh Commissioning, including compliance with laws and any export restrictions relating to the use of the BlueMesh Commissioning, at the place of usage and performance of the BLUEMESH Commissioning, in particular to obtain legal consent form the owner/tenant or the disposer of the property where the Lighting System and Devices are installed.
- (b) You shall not use the BlueMesh Commissioning in violation of these Terms of Use, any laws, regulations, or for any unlawful or abusive, unethical purpose; in any manner that in any application could harm BlueMesh or any other third party, persons or users (including, but not limited to, death, personal injury or severe physical or property damage).
- (c) You will not place false, illegal, misleading or any information that infringes or violates another

party's rights (in particular: intellectual property rights or flights of privacy or publicly) on the BlueMesh Commissioning.

- (d) You will not use or access any service, information, application or software available via the BlueMesh Commissioning in a manner not expressly permitted by BlueMesh.
- (e) You will not input or upload to the BlueMesh Commissioning any information which contains viruses, Trojan horses, worms, time bombs or other computer programming routines that are intended to damage, interfere with, intercept or expropriate BlueMesh Commissioning or that infringes the Intellectual Property rights of another.
- (f) You shall not disguise the origin of information transmitted through the BlueMesh Commissioning.

- (g) You may not use or access the BlueMesh Commissioning in any way that, in BlueMesh judgment, adversely affects the performance or function of the BlueMesh Commissioning or interferes with the ability of authorized parties to access the BlueMesh Commissioning.
- (h) You may not frame or utilize framing techniques to enclose any portion or aspect of the Intellectual property, without the express written consent of BlueMesh.

6. Updates and upgrades

You acknowledge that BlueMesh Commissioning may be modified from time to time, in particular in the scope of the security of BlueMesh Commissioning. Therefore any aspect of the BlueMesh Commissioning may be changed, supplemented, deleted, updated or upgraded. BlueMesh may make such modifications or changes to the BlueMesh Commissioning at any time at its sole discretion and without notifying you.

7. Termination

You agree that BlueMesh, at its sole discretion, may terminate or suspend your use of the BlueMesh Commissioning in particular (i) to protect the BlueMesh Commissioning and BlueMesh, as otherwise described in the separate agreements, or (ii) if You act in violation with these Terms of Use, Documentation or applicable law (e.g. in case of configuration of the lighting devices which are not qualified by BlueMesh, violation of third party intellectual property rights), or (iii) You do not use of the BlueMesh Commissioning for at least one year.

You are entitled to terminate the use of the BlueMesh Commissioning at any time (see sec. 3 above), in particular in case you don't agree to the update or upgrade provided by BlueMesh.

Upon such suspension or termination, You are not entitled to use the BlueMesh Commissioning and must immediately discontinue use of the BlueMesh Commissioning. Accessing the BlueMesh Commissioning or Information after such termination, suspension or discontinuation shall constitute an act of trespass. Further, you agree that BlueMesh: (a) upon termination or suspension is entitled to delete all data and information concerning usage of the BlueMesh Commissioning by You; (b) shall not be liable to you or any third party for any termination or suspension of your access to the BlueMesh Commissioning and/or Information.

Your User Content is stored by BlueMesh when You use BlueMesh Commissioning. However, upon termination of such use of the BlueMesh Commissioning User Content (without any personal data), might be: visible to other users who act as a "project owner" in the BlueMesh Commissioning and accept these Terms of Use.

Subject to the provision of these Terms of Use, the provisions of Clauses 7, 8, 10-15 shall survive the termination of the use of BlueMesh Commissioning.

8. Privacy

By using the BlueMesh Commissioning you may be asked to provide personal data (e.g. name, email address, company, phone number, country of residence). We may obtain information in connection with various activities such as (i) use of BlueMesh Commissioning, (ii) commissioning activities for Lighting Devices, including Bluetooth mesh provisioning and configuration of such devices, (iii) creating Account, (iv) and contacting you with regard the BlueMesh Commissioning.

BlueMesh or its technology partner collects data processes and collects your data in accordance with the BlueMesh Commissioning Privacy Notice available at <u>www.BlueMesh.us</u>. The BlueMesh Commissioning Privacy Notice governs the use of information collected from or provided by you by the BlueMesh Commissioning. This includes your personal data as defined in the BlueMesh Commissioning Privacy Notice. With respect to any individual whose personal information is provided by you, you represent that you have obtained all necessary consents for the processing of such personal data contemplated by the BlueMesh Commissionings you are using and by the BlueMesh Commissioning Privacy Notice.

PLEASE READ ABOUT PERSONAL AND OTHER DATA PROCESSED BY BLUEMESH AND ITS USE AS WELL EMPLOYED PRIVACY SAFEGUARDS IN BLUEMESH COMMISSIONING PRIVACY NOTICE BEFORE USING THE BLUEMESH COMMISSIONING. Nevertheless, the BlueMesh Commissioning obtains, uses and stores commissioning data which reflects the configuration of the Devices set up using the BlueMesh Commissioning. The dataset may include mesh data and mesh metadata (organization, installation and Device information) and in particular the mesh crypto data. BlueMesh performs anonymization and aggregation of such data, unless it impedes or makes the performance of the BlueMesh Commissioning impossible. You agree and acknowledge that the intellectual property rights to such data belong exclusively to BlueMesh and BlueMesh may use such data to: analyze, enhance and improve the BlueMesh Commissioning (including developing new features and services), process information regarding Devices (particularly mesh model parameters, mesh subscription lists, mesh composition data, general mesh parameters and commissioning dates), process information regarding the commissioning steps, create and update Device configuration; configure Device behavior, provide additional services to you directly in Lighting System.

9. Fee

Unless otherwise expressed in the separate agreement, BlueMesh provides you with the BlueMesh Commissioning free of charge.

BlueMesh may provide certain additional and payable BlueMesh Commissioning features, functionalities, Installation Profiles and associated services as well. BlueMesh may also limit non-payable space for User Content storage, introducing fees for the storing of particular amounts of data.

Furthermore, you accept that some of the functionalities of the BlueMesh Commissioning may require purchasing and installation of the gateway devices, under separate agreement. If you are interested in the above, please contact BlueMesh.

10. Warranties & Liability

You agree to use the BlueMesh Commissioning in strict compliance with all applicable laws, rulings and regulations and in a fashion that does not, in the sole judgment of BlueMesh, negatively reflect on the goodwill or reputation of BlueMesh and shall take no actions which would cause BlueMesh to be in violation of any laws, rulings or regulations applicable to BlueMesh.

Except for the warranties indicated in these Terms of Use or a separate agreement, the BlueMesh Commissioning is provided "as-is" and BlueMesh specifically disclaims any and all express, implied or statutory warranties, including the implied warranties of fitness for a particular purpose, and of merchantability and against infringement. No person is authorized to make any warranty or representation on behalf of BlueMesh concerning the performance of the BlueMesh Commissioning. For the avoidance of doubt, it is not a breach of this Clause for the third party to provide warranties on Lighting Devices provided by the third party that are required by local law or regulations, in its own name.

NOTWITHSTANDING ANY OTHER PROVISION OF THE AGREEMENT OR ANY PURCHASE ORDER, BLUEMESH SHALL NOT BE LIABLE TO THE OTHER OR ANY THIRD PARTY FOR INDIRECT, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES OF ANY NATURE INCLUDING WITHOUT LIMITATION LOSS OF PROFIT, MANUFACTURING EXPENSES, OVERHEAD, DATA, INJURY TO REPUTATION OR LOSS TO YOU, ARISING OUT OF OR IN CONNECTION WITH THE USE OF BLUEMESH COMMISSIONING, INCLUDING THE PURCHASE, SALE, PERFORMANCE OR FAILURE OF THE BLUEMESH COMMISSIONING, WHETHER SUCH

LIABILITY ARISES UNDER CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT PRODUCT LIABILITY OR OTHERWISE, EVEN IF (I) BLUEMESH OR YOU HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR (II) SUCH DAMAGES COULD HAVE BEEN REASONABLY FORESEEN.

You also acknowledge that proper performance of the BlueMesh Commissioning depends on the external factors beyond BlueMesh's control, in particular on proper functioning (including environmental factors), configuration and installation (in proper manner and according to the technical requirements) of the Devices and the Lighting System, connectivity and communication system used to operate the Devices and the Lighting System. Therefore, BlueMesh has no responsibility and liability in this respect thereof and BlueMesh is not liable for any damages and claims caused by such factors beyond BlueMesh's control.

BlueMesh reserves the right to introduce a break in the operation of the BlueMesh Commissioning or its certain functionalities. If there is an intention to implement a break, BlueMesh will notify You about it by posting relevant information or a message in the BlueMesh Commissioning.

NOTWITHSTANDING ANY OTHER PROVISION OF THESE TERMS OF USE OR ANY PURCHASE ORDER OR ANY OTHER AGREEMENT OR WRITING BETWEEN YOU AND BLUEMESH, AND TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, IN NO EVENT WILL A BLUEMESH'S LIABILITY ARISING OUT OF OR RELATING TO THESE TERMS OF USE OR THE AGREEMENT, INCLUDING WITH REGARD TO THE USE OF THE BLUEMESH COMMISSIONING AND COMMISSIONING OF LIGHTING DEVICES, EXCEED \$ 1,000. THE FOREGOING LIMITATIONS WILL SURVIVE AND APPLY NOTWITHSTANDING THE FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY SET FORTH HEREIN.

Except for obligations to pay money, neither Party will incur any liability to the other Party on account of any loss or damage resulting from any delay or failure to perform all or any part of the Agreement if such delay or failure is caused, in whole or in part, by events, occurrences or causes beyond the reasonable control of the Parties. Such events, occurrences or causes will include, without limitation, acts of God, strikes, lockouts, riots, acts of war, pandemia, failures of the Internet, earthquakes, fire and explosions, but the inability to meet financial obligations is expressly excluded.

BlueMesh shall not be liable for the consequences of installing or sending any malicious software, phishing or any other practices undertaken by other entities to the BlueMesh Commissioning.

11. Jurisdiction

To the fullest extent permitted by law, you hereby expressly agree that any proceeding arising out of or relating to your use of the BlueMesh Commissioning, Information and content shall be instituted in a court competent for the registered office of the BlueMesh in Canada, and you expressly waive any objection that you have now or hereafter to the selection of the venue or to the jurisdiction of any such proceeding. You agree that any claim or cause of action arising out of or related to your use of the BlueMesh Commissioning, Information and content must be filed within one (1) year after such claim or cause of action arose.

12. Governing Law and Language

The controlling language for these Terms of Use and the BlueMesh Commissioning is English.

The validity, interpretation, construction and performance of these Terms of Use and all acts and transactions pursuant hereto and rights and obligations of BlueMesh and You hereto shall be governed, construed and interpreted in accordance with the laws of C a n a d a , without giving effect to principles of conflicts of law that would result in the application of the laws of another jurisdiction. All disputes arising out of or related to these Terms of Use shall be finally settled under the Rules of arbitration of the International

Chamber of Commerce by one or more arbitrators appointed in accordance with the said Rules. The seat of arbitration shall be Vancouver, Canada. The language to be used in the arbitral proceedings shall be English.

13. Export restriction

The BlueMesh Commissioning is based in north america. The applicable jurisdictions control the export of products and information. You agree to comply with all such applicable restrictions and not to export or re-export any portions of the BlueMesh Commissioning to countries or persons prohibited under the applicable export control laws or regulations. If you access and download the content or Information, you represent that you are not in a country where such export is prohibited or are not a person or entity to which such export is prohibited. You are solely responsible for compliance with the laws of your local jurisdiction and any other applicable laws regarding the import, export, or re-export of the content.

14. Miscellaneous

Unless otherwise expressed in the Terms of Use, You may not assign these Terms of Use or any of your interests, rights or obligations under these Terms of Use.

If any term, condition or provision of the Terms of Use or portion thereof is found to be invalid, unlawful or unenforceable to any extent, the Parties shall proceed under the law chosen to govern the Agreement. Such an invalid term, condition or provision will be severed from the remaining terms, conditions and provisions, which will remain valid and enforceable to the fullest extent permitted by law.

Except as expressly provided in a separate license, service or other written agreement between You and BlueMesh, these Terms of Use and Documentation constitute the entire agreement between You and BlueMesh with respect to the use of BlueMesh Commissioning, Information and content contained therein, and supersede all discussions, communications, conversations and agreements concerning the subject matter hereof.

You may preserve these Terms of Use in written form by printing them for your records, and you waive any other requirement that these Terms of Use be evidenced by a written document.
